The Benue State Emergency Management Agency (BSEMA) in partnership with the office of United Nations High Commissioner for Refugees (UNHCR), Nigeria, is supporting the delivery of water services in Tatyough community and surrounding villages, in Makurdi local Government Area of Benue State.

BENUE- SEMA now invites bids from suitably qualified contractors for the procurement of 3 new solar boreholes, 1 solar borehole upgrade, and 11 rain water harvester schemes at Tatyough community and surrounding villages of Ayaka, Igbo, Anule, and herders camp at Dawudu villages, respectively.

We, the undersigned, offer to execute in conformity with the Conditions of Contract and associated Contract Documents, the following Works and Related Services, viz:

### **Under Lot:**

Lot 1: Solar installation, construction steel tower to hoist 2 x 5,000 litres plastic tanks x 9m height steel tower on the existing 170m depth borehole, reticulated to 300m distance, and a 3mx3mx1m (using 225x225x450 sandcrete blocks) tap stand) and installation of 5 heavy duty pressure release 3/4' taps on concrete platform, well tiled, in a space provided in Tatyough community including covered soak pit of 1m x 1.5m x 1m height.

Lot 2: Drilling and installation of 2 new solar boreholes of 2 x 5,000 litre plastic tank placed on 9m height H-iron steel tower and reticulated to a total distance of 500m with a 2m length x1.5 m width x 0.3m height concrete (using 225mm sandcrete blocks) tap stand installed with 5 heavy duty pressure release 3/4" taps, well tiled, in a location provided in the community including covered soak pit of 1m x 1.5m x1m for waste water collection at Ayaka and Anule villages near Tatyough community.

Lot 3: Drilling and installation of 1 new solar borehole of 2 x 5,000 litre plastic tank placed on 9m height steel tower, reticulated to 2 tap concrete stand (1 at Igbo village with dimension 2m length x1.5 m width x 0.3m height) while the  $2^{nd}$  collection point of dimension 5m x 2m x 0.5m concrete trench, located 1000m towards the herder route.

### Lot 4

- a. Construction of 3 No. Concrete reservoir Rainwater Harvestation of dimension 4m length x 3.5 width x 2.5 height using 225" block work with re-enforced concrete columns and decking, installed with AfriDev hand pump and improvised zinc roof catchment (using Cameroonian zinc sheets) connected to the ground reservoir at Tatyough, Ayaka PHC, and RCM Primary school Tatyough; and
- b. Construct 8 No. rain harvesters using 5,000l plastic surface tanks placed on 0.5 concrete base, and connected to improvised zinc roof catchment (using Cameroonian zinc sheets) at Dawudu herders camp by the Benue riverside.

Contractors are at liberty to bid for all the lots or a part of the lots. However, this should be stated clearly in the forwarding letter of the biding company. Bids will be valid for the period stated in the ToR to Bidders and it shall remain binding upon us and may be accepted at any time before the expiration of that period.
